The following nationalities can apply for a **Turkey e-Visa online**:

- Africa: Algeria, Burkina Faso, Cameroon, Cape Verde, Egypt, Equatorial Guinea, Guinea, Mauritius, Mauritania, Senegal, South Africa.
- Asia-Pacific: Bangladesh, Bhutan, Cambodia, China, India, Maldives, Nepal, Pakistan, Philippines, Sri Lanka, Taiwan, Vietnam.
- Europe and Caribbean: Armenia, Cyprus, Dominican Republic.
- Oceania: Australia, Fiji, Solomon Islands, Vanuatu.
- Latin America: Antigua and Barbuda, Bahamas, Barbados, Bermuda, Grenada, Jamaica, Mexico, Saint Lucia, Saint Vincent and the Grenadines, Suriname.

Citizens Who Are Allowed Entry Without a Visa:

Turkey allows citizens of the following European countries to enter without a visa:

- Belgium
- Austria
- The Netherlands
- Poland
- Spain
- The United Kingdom.

Application Steps

Step 1: Visit the Turkey e-Visa Portal:

Navigate to https://www.turkey-e-visas.com and click on "Apply Now."

Step 2: Fill in Personal Information:


- Full Name. (as per passport)
- Passport Number and Expiry Date.
- Date of Birth and Nationality.

Step 3: Select Visa Type and Purpose:

• Choose your travel reason **Tourism** or **Business** and specify the length of stay.


Step 4: Payment Section:

- Payment of e-Visa using the secured website payment gateway.
- Accepted methods: Credit/Debit Card.



Required Documents:

- Passport Copy: Must be valid for at least 6 months from the travel date.
- Travel Itinerary: optional for some types.

- Processing Time: Typically 24 hours, but urgent visas are processed within 1-2 hours.
- **Process & Double Check**: Process the e-Visa application. Double-check the application form for spelling of names and dates or for any missing information.
- **Rejection Warning**: Do not use outdated passports.
- **Conformation:** Ensure you check your email for the confirmation for your approved e-Visa.

Q5: Can I use any passport for the e-Visa application if I have dual nationality?

A5: No, you must select the nationality corresponding to the passport you will use for travel. If the e-Visa details don't match your passport, the e-Visa will be invalid.
