





## 🖏 Additional Requirements Based on Sticker Visa Type.

Depending on the type of visa being applied for (tourist, business, student, etc.), additional documents may be required:

#### Tourist Visa:

- Hotel Reservations: Confirmed hotel bookings for the duration of the stay.
- Tourist Activities: Any planned tours or activities, if applicable.

#### **Business Visa:**

- Invitation Letter: A letter from the Turkish company inviting the applicant for business purposes.
- **Company Registration**: Proof of the applicant's employment or business registration.

#### **Student Visa:**

- Acceptance Letter: An official admission letter from a Turkish educational institution.
- **Proof of Accommodation**: Evidence of accommodation arrangements in Turkey.
