#### Overview.

Complete the online form with accurate personal and passport details.

## **Review and Payment**

#### Receive e-Visa

Upon approval, the e-Visa is sent to your email. Print and carry it during your travel.

#### **X** Validity and Duration.

- Validity Period: The e-Visa is valid for 180 days from the date of issue.
- **Duration of Stay**: Depending on nationality, travelers can stay for **30** to **90 days** within the validity period.
- Entry Types: Single or multiple entries are granted based on the applicant's nationality.

## Essential Guidelines for Turkey e-Visa Applicants.

- A passport with at least 6 months of validity from the date of arrival in Turkey.
- Carry a printed copy of your e-Visa when traveling.
- Turkey e-Visa is available for eligible travelers via an online portal.
- The e-Visa fee varies depending on **nationality** and **visa type**.
- The process is quick and generally takes minutes to complete.
- The e-Visa allows **single** or **multiple entries**, depending on the applicant's nationality.
